Congratulations on your recent appointment as a department Benefits Protection Team Leader (BPTL). Whether you are new to this position or have been reappointed, DAV appreciates your commitment to taking on the responsibilities of serving in this important position. The legislative team looks forward to working with you this year as we continue the BPTL program's legacy of success.

DAV has fought many battles on behalf of our nation's service-disabled veterans during our more than 100-year history, and these veterans, their families, caregivers and survivors have been well-served by DAV's grassroots advocacy efforts.

Over the past 12 months, key efforts by BPTLs resulted in the passage of the historic Honoring our PACT Act. This new law expands VA health care and benefits for veterans exposed to burn pits and other toxic substances and will provide generations of veterans—and their survivors—with the care and benefits they've earned and deserve. DAV's grassroots advocacy also resulted in the passage of legislation to improve VA mental health services, suicide prevention efforts and programs and services for women veterans.

I know that your leadership and advocacy will help to ensure DAV's legislative priorities remain at the forefront of federal lawmakers' agendas and that you will do your part to ensure that the promises made by our government to the men and women who served are kept.
